Minutes of the 76th Annual General Meeting of Forrest Little Golf Club

The Chairman declared the meeting open and welcomed the members present.

The Honorary Secretary confirmed that a quorum (40 members) was present. 80 members signed the attendance sheet

A minute's silence was then held for the deceased members.

Honorary Treasurer's Report

The Honorary Treasurer's report, having already been circulated in advance, was adopted.

The Honorary Treasurer Michael O'Sullivan went through a powerpoint presentation on screens to clarify aspects of the Financial Report.

While the club's income at €792k was down €20k on previous year, the income was funded mainly by annual subscriptions. All income headings performed well and the new members deal of €100 per month proved popular and helped to attract additional members.

On the expenditure side costs were well controlled and total costs were down €49k on last year. The Treasurer thanked Paul Keane, his subcommittee and all the ground staff for their efforts with

special thanks also to the large team of volunteers helped with Course, Clubhouse etc. Michael also called for a well-earned round of applause for all the volunteers.

In summary, Income v expenditure saw a €35k operating surplus. On the capital side development levy less €17k spent on entrance hall upgrade, left a capital surplus €27k. When this is combined with the operating surplus of €35k shows an overall surplus of €62k. This funded bank repayments of €59k. The trend is good with the balance sheet €74k better off this year.

Budget for 2016 shows income increase with new members included for the full year and continuing expenditure controls in place helping the bottom line move towards an €80k surplus. Capex plans include work on minimum of 6 bunkers.

Michael went on to advise that there was no subscription increases proposed for 2016 and furthermore the Loyalty Card would revert to 100% allocation to the loyalty card. This reverses the current allocation where \pounds 25 of the \pounds 100 is allocated towards subscriptions.

In closing Michael thanked our auditor Kevin Hampson, Paddy & Margaret in office and Captain Gerry Healy and Council for all their support during the year.

Marketing and Membership Presentation

Prompted by a fall-off in membership enquiries in February, an initiative to attract new members was launched at €100 per month was introduced and we attracted 46 new members, 11 Intermediate and 5-day and 24 Juvenile and Juniors. In response to competition from other clubs this action was a prudent necessary and well timed move.

Membership Flyers were distributed through our pro shop and McGuirk's shops, and an incentive €100 payment to members for attracting new full members was introduced.

A detailed Membership Survey was completed to assist in developing strategy for the future. Huge response with over 70% response rate.

In general members were satisfied with most areas, however specific focus areas determined were:-

Course – Bunkers Pro Shop, Bar and Restaurant - Members sought more special offers Clubhouse – Main lounge, Gents toilets and showers Communications – Monthly Newsletters

Membership numbers have stabilised with 82 new members across all categories. Main reasons for joining were Family/Friends, Location, Course and Price

103 members on Leave of absence of which 84 were fully paid up members last year.

Other key issues covered by Marketing and Membership included

- Rebranding 75th anniversary clothing through the Pro Shop
- Events team ran a super Jubilee Year program
- Jubilee Clock unveiled (also known as Gerry Healy's clock)
- Entrance Hall upgraded for 1st time in over 15 years
- Pro shop had alterations also
- Dress code was renewed
- Web Site and Social Media updates undertaken

That rule 4.8.5 be altered to read

Any member whose first subscription payment is not paid by the thirty first day of December, shall cease to be a member of the Club for the following calendar year. Any member whose outstanding balance is not paid by the thirty first day of March in any year, shall cease to be a member of the Club from that day. However the Council may, by the vote of three-fourths of the members present, suspend or modify the application of the rule to any member on reasonable cause being shown.

General

Joe Fitzpatrick asked for clarification on Motion no 3 when it was explained that 50% of the subs fall due on 1st October and must be paid by end December, the second half of the subs fall due on 1st January and must be paid by end March.

Martin Kelly queries if those paying subs in full before end of December would have the loyalty card €100 allocated to their card when payment was made. This is not possible as the club retains any unused loyalty card balance at end December and therefore adding funds to the card at this time is not possible.

Joe Cummins commented that when we lost one of our Trustees the course was closed until midday as mark of respect. He asked why some members were allowed play before noon
